\$1.1 Million Ready Set Win Virtual Drawing Promotion May-June 2022

- MUST BE AN MGM REWARDS MEMBER. MGM REWARDS MEMBERSHIP IS FREE to all patrons who are 21 years of age or older. NO PURCHASE NECESSARY.
- Empire City Casino at MGM Yonkers will host the \$1.1 Million Ready Set Win each Saturday in May and June 2022. Drawings will take place each hour from 6pm-10pm.
- Participants may receive information about this promotion in several ways including, but not limited to, their monthly mailer and traditional advertising methods.
- During the entry period from May 1st through June 25th at 9:44:59 PM, MGM Rewards Members will receive one FREE entry for visiting any Rewards Kiosk, good for one redemption during the promotional period. Members receive additional entries for every \$1 Slot Dollars earned on any slot machine or electronic table game.
- MGM Rewards members may multiply earned entries each Monday during the entry period. Members must visit a Promotions Kiosk during the gaming day to determine a multiplier from 2x to 10x. Bonus entries may take up to 48 hours to appear on MGM Rewards account.
- Members are responsible for activating their entries by registering any carded rating within two hours of the drawing time on the drawing date.
- Winning names will be drawn 15 minutes prior to each hourly announcement to allow for proper verification.
- At each hourly drawing, winners' names will be randomly selected from all eligible participants via computer-generated selection process at a designated player tracking station.
- Participants may not win more than once per drawing session. In the event of a duplicate winner in standard drawings, an alternate will be drawn until a total of 20 unique winners are drawn.
- Once winners' names are verified, the names will be announced via public address system on the gaming floor. Winners' names will be displayed at the drawing location and on the Media Pods located throughout the property as technology is available.
- Participants must be present to win. At each drawing, winners will have 10 minutes to claim their prize. No alternates will be drawn.
- On Standard Drawing days, 20 winners will be drawn each hour. Prizes will be determined by playing our Wheel. Available prize amounts vary by hour. Freeplay prizes are not valid on any electronic table games.

- On Standard Drawing Days, May 14th, May 21st, June 11th, and June 18th, at 10:00pm, 20 winners will be called to play a slot tournament for Cash or Freeplay. Available prize amounts are as follows:

This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a video lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and prizes will be forfeited automatically.
