\$325,000 Winning Wonderland Virtual Drawing Promotion

November - December 2020

1. **MUST BE AN M LIFE REWARDS MEMBER. M LIFE REWARDS MEMBERSHIP IS FREE** to all patrons who are 21 years of age or older. **NO PURCHASE NECESSARY.**

2. Empire City Casino at MGM Yonkers will host the \$325,000 Winning Wonderland each Friday in November and December. Drawings will take place from 5pm-9pm each evening.

3. Participants may receive information about this promotion in several ways including, but not limited to, their monthly mailer and traditional advertising methods.

4. During the entry period from November 1st- December 18th at 8:44:59 PM, M life Rewards Members will receive entries for every 50 Points earned on any slot machine or electronic table game.

5. Members are responsible for activating their entries by registering any carded rating within two hours of the drawing time on the drawing date.

6. Winning names will be drawn 15 minutes prior to each hourly announcement to allow for proper verification.

7. At each hourly drawing, 20 winners' names will be randomly selected from all eligible participants via computer-generated selection process at a designated player tracking station.

8. Participants may not win more than once per drawing session. In the event of a duplicate winner, an alternate will be drawn until a total of 20 unique winners are drawn.

9. Once winners' names are verified, the names will be announced via public address system on the gaming floor. Winners names will be displayed at the drawing location and on the Media Pods located throughout the property as technology is available.

10. Participants must be present to win. At each drawing, winners will have 10 minutes to claim their prize. No alternates will be drawn.

11. Prizes will be determined by the order in which winners are drawn in descending order. Prize amounts vary by hour. Freeplay prizes are not valid on any electronic table games.

This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a video lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and prizes will be forfeited automatically.
