- MUST BE AN MGM REWARDS MEMBER. MGM REWARDS MEMBERSHIP IS FREE to all patrons who are 21 years of age or older. NO PURCHASE NECESSARY.
- Empire City Casino at MGM Yonkers Inc. will host \$100K Host Invitational Drawings on November 2nd, 9th, 16th, and 30th.
- Participants may receive information about this promotion in several ways including, but not limited to, traditional advertising methods.
- Empire City Casino will host drawings for Invited members every half hour from 6:00pm-9:30pm.

- MGM Rewards Members are responsible to ensure their MGM Rewards Card is properly inserted and registered into an eligible machine within one (1) hour of any drawing time.

- Winner names will be announced over the public address system and/or displayed on the media pods located on throughout the property if the technology is available.

Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion.
