4. Each promotional date, Empire City Casino will host drawings for MGM Rewards™ Members every fifteen minutes from 4:15pm-8:00pm.

5. To qualify, MGM Rewards™ Members must earn \$0.50 Slot Dollar during the promotional gaming day and register play on any machine within 30 minutes of any drawing time.

6. MGM Rewards™ Members are responsible to ensure his or her MGM Rewards™ Card is properly inserted and registered into an eligible machine at the time of the promotion.

This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a video lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and prizes will be forfeited automatically.
