- MUST BE AN MGM REWARDS MEMBER. MGM REWARDS MEMBERSHIP IS FREE to all patrons who are 21 years of age or older. NO PURCHASE NECESSARY.
- Empire City Casino at MGM Yonkers Inc. will host the \$160,000 Double Trouble Tournaments every Tuesday and Friday in November 2023.
- Participants may receive information about this promotion in several ways including, but not limited to, their monthly mailer and traditional advertising methods.
- Empire City Casino will host drawings for invited MGM Rewards Members every half hour from 3:30PM to 6:00PM on Tuesdays and from 6:30PM to 9:00PM on Fridays.
- To qualify, MGM Rewards Members must earn \$0.50 Slot Dollars during the promotional gaming day and register play on any machine within 30 minutes of any drawing time.
- Drawings on Tuesdays for Sapphire and Pearl Members will take place at 3:30pm, 4:30pm, and 5:30pm. Drawings for Gold, Platinum and Noir Members will take place at 4:00pm, 5:00pm, and 6:00pm.
- Drawings on Fridays for Sapphire and Pearl Members will take place at 6:30pm, 7:30pm, and 8:30pm. Drawings for Gold, Platinum and Noir Members will take place at 7:00pm, 8:00pm, and 9:00pm.
- MGM Rewards Members are responsible to ensure his or her MGM Rewards Card is properly inserted and registered into an eligible machine at the time of the promotion.

This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a video lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion.
