- MUST BE AN MGM REWARDS MEMBER. MGM REWARDS MEMBERSHIP IS FREE to all patrons who are 21 years of age or older. NO PURCHASE NECESSARY.
- Empire City Casino at MGM Yonkers will host the \$450,000 Tournament of Champions Saturday in January and February 2024. Drawings will take place from 6pm-10pm each evening.
- Participants may receive information about this promotion in several ways including, but not limited to, their monthly mailer and traditional advertising methods.
- During the entry period from December 30th at 10:00 pm through February 24th at 9:44:59 PM, MGM Rewards Members will receive one FREE entry for visiting any Rewards Kiosk, good for one redemption during the promotional period. Members receive additional entries for every \$.50 Slot Dollars earned on any slot machine or electronic table game.
- Members are responsible for activating their entries by registering any carded rating within two hours of the drawing time on the drawing date.
- Winning names will be drawn 15 minutes prior to each hourly announcement to allow for proper verification.
- At each hourly drawing, winners' names will be randomly selected from all eligible participants via computer-generated selection process at a designated player tracking station.
- Participants may not win more than once per drawing session. In the event of a duplicate winner in standard drawings, an alternate will be drawn until a total of 20 unique winners are drawn.
- Once winners' names are verified, the names will be announced via public address system on the gaming floor. Winners' names will be displayed at the drawing location and on the Media Pods located throughout the property as technology is available.
- Participants must be present to win. At each drawing, winners will have 10 minutes to claim their spot at the tournament location. No alternates will be drawn.
- On Standard Drawing days, 20 winners will be drawn each hour. Prizes will be determined by playing a slot tournament for 1 minute. Available prize amounts vary by hour. Freeplay prizes are not valid on any electronic table games.
- Each Saturday on standard days, at 10pm, first place winner will receive \$500 in Freeplay and one golden ticket which guarantees a spot for a Grand Prize Semi-Final for that month. Golden Ticket active date will be determined by a Marketing Representative prior to each drawing.
