



OFFICIAL RULES

MGM Millions

Kiosk Ticket Promotion

Saturdays in March and April

2023

1. MUST BE AN MGM Rewards™ MEMBER. MGM Rewards™ MEMBERSHIP IS FREE to all patrons who are 21 years of age or older. NO PURCHASE NECESSARY.

2. Empire City Casino at MGM Yonkers Inc. will host MGM Millions promotion Saturdays in March and April 2023. Drawings each promotional date will be held at 3pm, 5pm, 7pm, and 9pm.

3. Participants may receive information about this promotion in several ways including, but not limited to, their monthly mailer and traditional advertising methods.

4. MGM Rewards™ Members may receive one MGM Millions Game Ticket each promotional week via the following methods:

a. Game Tickets can be redeemed from any Promotional Kiosk any time during the active promotional week for drawings that Saturday.

b. Each Game Ticket will contain 6 entry numbers for MGM Millions drawings. The 6 random numbers will be supplied randomly via the Promotional Kiosk.

c. Game Tickets are only valid for the promotional week in which printed and do not carry over to additional weeks.

d. MGM Millions Game Tickets must be claimed at least one minute prior to the nearest drawing time or will not be eligible for said drawing. Game Tickets claimed within the one-minute window of the nearest drawing will only be eligible for subsequent drawings.

e. Game Tickets claimed after the last drawing will be eligible for the following drawing date.

5. MGM Millions Game:

a. On each promotional date at each drawing time, 3pm, 5pm, 7pm, and 9pm, 6 winning numbers will be drawn via MGM Millions machine (provided by Odds On Promotions). Each drawing time, the 6 numbers will be announced throughout the casino floor and displayed on the media pod screens throughout the casino floor.

b. Activating MGM Millions Game:

i. A push of the "Red" button by an Empire City Casino representative causing balls to collect in the chamber will constitute a play. In the event all 6 balls do not collect in the chamber a new draw will be done.

ii. The FIRST SIX (6) balls collected in the chamber will be eligible for a prize award as defined below.

Match 6 of 6	\$1,000,000 Cash
Match 5 of 6	\$5,000 Cash
Match 4 of 6	\$500 FREEPLAY®
Match 3 of 6	\$50 FREEPLAY®
Match 2 of 6	\$15 FREEPLAY®

iii. MGM Rewards™ Members can visit any Promotional kiosk or the designated promotional area to claim their prize.

iv. To win a prize, guests must match numbers with the numbers that were drawn from MGM Millions Game machine. MGM Rewards™ Members will have 2 hours from the drawing time to claim prizes matching 3 numbers or less, winners matching 4 or more numbers must claim their prize within one (1) hour of drawing time. If a contestant fails to appear within the allotted time period, the prize will be forfeited.

v. To claim, prize winners must have received a Game Ticket/s indicating 2 or more winning numbers. 1. All winning Game Tickets must contain the account number for the MGM Rewards™ Member that is redeeming a prize.

2. Prizes for 4+ matching numbers require independent verification by Empire City Casino's officials. A winner payout form will be completed for each cash prize awarded and the winner will be escorted to the cage window. Winners will be required to present their MGM Rewards™ Card and proper ID to collect their prize.

3. All free play prizes for 3 or less matching numbers will be available for claim at any Promotional kiosk.

vi. Empire City Casino at MGM Yonkers Inc. is not responsible for lost, stolen or mutilated Game Tickets. Once the promotion concludes on drawing dates, all weekly Game Tickets are void.

vii. Unclaimed prizes will be forfeited.

6. IMPORTANT: In the event of a play resulting in a draw eligible for \$1,000,000 a promotion official must: (a) secure the first six (6) balls drawn in the chamber and (b) take photographs showing all six (6) balls secured in the chamber with the winning contestant standing next to the machine.

a. Prize for six (6) match numbers must be claimed within one (1) hour of the applicable drawing time.

b. Prize for six of six matched numbers may be subject to parameters set forth by Odds On Promotions. Payment of prize subject to award schedule set forth by vendor.

7. Empire City Casino is not responsible for any prize reimbursement resulting from machine malfunction.

8. OPENING AND/OR TAMPERING WITH MGM MILLIONS MACHINE IS STRICTLY PROHIBITED. Evidence of unauthorized entry or any act or submission that changes the odds or functionality of the machine will cause prize forfeiture.

9. Participants must be present to win. Winner must be present at the time of payout in order to receive a prize and participate in MGM Millions Game. At no time will late payouts or participation be authorized. If a contestant fails to appear, the prize will be forfeited.

10. Winners of FREEPLAY® will have two (2) hours after the applicable drawing time to claim their prize.

11. Winners of Cash prizes will have one (1) hour after the applicable drawing time to claim their prize.

12. Empire City Casino may adjust prizing and parameters for claim based on kiosk errors or malfunctions. Prizing may be limited to only active participants that have registered play on the promotional date.

13. Empire City Casino will only award up to one \$1,000,000 Grand Prize during the life of the promotion. In the event an eligible contestant wins the \$1,000,000 prize, any additional cards with 6 matching numbers will receive \$15,000.

14. Total winners and prizes: Total value of the prizes awarded during the course of the promotion will depend on the prize amounts claimed.

15. No assignment or transfers of prizes allowed. Odds of winning depend on number of eligible participants.

16. Winners must present MGM Rewards™ card and valid government-issued photo identification. In addition, Members must provide proof of their Social Security number by presenting a Social Security Card or by completing a W-9 form or similar document, as necessary to comply with Federal tax reporting requirements. Winners are responsible for any United States Federal, State or local taxes and/or any fees that may be imposed in connection with the acceptance of any prize.

17. A winner payout and release form must be completed by participants and a casino representative prior to awarding any cash prizes.

18. To process your prize claim, you authorize Empire City Casino to collect personal information about you.

19. Falsification of any information will result in ineligibility to claim any prize.

20. Empire City Casino at MGM Yonkers Inc. may require additional information, notarized statements, or other evidence, as it may deem appropriate, to be supplied by a prize winner.

21. Each prize winner grants to Empire City Casino at MGM Yonkers Inc. the right to use their name, city of residence, and photograph in order to publicize their winnings. The name and city of residence of prize winners shall be regarded as public information; however, it shall be the policy of Empire City Casino at MGM Yonkers Inc. not to release the street address or telephone number of the prize winners, except as may be required pursuant to lawful authority or urgent necessity. At the discretion of Empire City Casino at MGM Yonkers Inc., photographs of winners may be taken and used for publicity or to compile a photographic record of winners.

22. Eligibility. The following persons or categories of persons are not eligible to participate in the promotion or win any prize; any officer or employee of the New York State Division of the Lottery, a principal, key employee or employee of any video lottery gaming agent licensed pursuant to this part, except as may be permitted by the Division for good cause shown, any licensee, registrant, contractor, subcontractor, or consultant, or officer or employee of a contractor, subcontractor, licensee, registrant or consultant, if such person is directly involved in the operation of video lottery gaming, the operation or observation of video lottery gaming or drawings, or the processing of video lottery gaming prize claims or payments, any person subject to a contract with the Division if such contract contains a provision prohibiting such person from purchasing a video lottery gaming ticket or receiving a video lottery gaming prize, any officer or employee of Empire City Casino at MGM Yonkers Inc., Brian Boru of Westchester, Inc., Delta Electric, or their affiliates or subsidiaries, any spouse, child, brother, sister, or parent of any of the foregoing persons. This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a video lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and prizes will be forfeited automatically.

23. Each entrant and winner shall indemnify and hold harmless Empire City Casino at MGM Yonkers Inc. and Yonkers Racing Corporation, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from his or her participation in this promotion. Empire City Casino at MGM Yonkers Inc. and Yonkers Racing Corporation assume no liability of any kind for any property loss or damage or personal injury occurring in connection with any prizes.
