



OFFICIAL RULES

\$120,000 Won-Day Virtual Drawing

Sundays in October & November 2022

1. MUST BE AN MGM REWARDS MEMBER. MGM REWARDS MEMBERSHIP IS FREE to all patrons who are 21 years of age or older. NO PURCHASE NECESSARY.

2. Empire City Casino at MGM Yonkers Inc. will host \$120,000 Won-Day Drawings every Sunday in October and November.

3. Participants may receive information about this promotion in several ways including, but not limited to, traditional advertising methods.

4. On the drawing dates Empire City Casino will host drawings from each hour from 6:00pm-8:00pm.

5. Members receive entries for every \$.25 Slot Dollars earned on any slot machine or electronic table game that day ONLY. Entries expire following each drawing date.

6. MGM Rewards Members are responsible to ensure their MGM Rewards Card is properly inserted and registered into an eligible machine within one (1) hour of any drawing time.

7. Drawings will take place at 6:00pm, 7:00pm, and 8:00pm.

8. At each drawing time, Winners' names will be randomly chosen from all eligible participants via computer-generated selection process at a designated player tracking workstation.

9. Winner names will be announced over the public address system and each contestant will have 10 minutes to appear in the designated promotion area. In addition, announcements will be broadcast via the public address system on the gaming floor and/or winners' names will be displayed at the drawing location and on the Media Pods located throughout the property if the technology is available.

10. If participants are not present after 10 minutes, prize will be forfeited. No alternates will be called.

11. Prize structure for each drawing is as follows. prizes are not valid on electronic table games.

12. Eligible guests may be drawn in each drawing time, each hour up to 3 times per promotional date.

13. Each participant may not win more than one prize per hour drawing and no more than 3 prizes each promotional date.

14. No assignment or transfers of prizes allowed. Odds of winning depend on number of eligible participants and entries.

15. Total Winners and Prizes: Prize amounts awarded are dependent on prize amounts claimed. There may be as many as 270 winners and a total of \$120,000 in FREEPLAY prizes.

16. Winners must present MGM Rewards Card and valid government-issued photo identification. In addition, Members must provide proof of their Social Security number by presenting a Social Security Card or by completing a W-9 form or similar document, as necessary to comply with Federal tax reporting requirements. Winners are responsible for any United States Federal, State or local taxes and/or any fees that may be imposed in connection with the acceptance of any prize.

This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a video lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and prizes will be forfeited automatically.

Each entrant and winner shall indemnify and hold harmless Empire City Casino at MGM Yonkers Inc. and Yonkers Racing Corporation, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from his or her participation in this promotion.
